I. Message from the Chairperson

I am honoured to have taken up this position on 1 February 2021. My two predecessors have established the Board and developed a solid foundation and roadmap for its work for the past 22 years. The past year has been unique and challenging in that we strived to continue with the hearing of applications and reviews amidst the COVID-19 pandemic. Thanks to the support of Board Members and our team of staff, we have managed to do so.

Several interesting developments took place in 2021. Responding to needs to enhance the transparency of our work, the Board introduced a new template and guidance notes for Monthly Statements to be used by guardians to take effect on 1 January 2022. A telephone recording system has been installed in the Secretariat. A website revamp project is underway.

Supported by the Labour and Welfare Bureau, developments in the Board had been ongoing. An expansion of the Secretariat, including staff structure and facilities, commenced on 26 September 2018. This phase included recruiting a Senior Legal Counsel and an additional Assistant Legal Clerk and opening our new Hearing Centre in Room 704, which has a more formal setting suitable for complex or legally represented cases.

In an ageing society, the Board must be braced for future challenges. While the Board's caseload is expected to increase, so should our specialization and knowledge. Our statistics show that the incidence of applications involving the elderly was 769 out of 1,012 cases while dementia related cases have risen from 65 to 107 in the reporting period. According to the figures published by the World Health Organization, there are currently more than 55 million people living with dementia worldwide, with nearly 10 million new cases every year. Besides being one of the major causes of disability and dependency among older people, dementia was recognized as having physical, psychological, social and economic impact also for their carers, families and society at large. We see the importance of early detection and treatment of cognitive impairment and making appropriate arrangement about it. Accidents and illnesses, such as brain damage or stroke, were harder to predict, but one could resort to the statutory safety net. The law provides a safety net to support individuals and families affected by all such cases enabling guardians to be appointed by the Board as a last resort for mentally incapacitated persons who are the subjects of our cases. are required under the guardianship orders to exercise their functions in the best interests of the subjects involved.

In performing its statutory functions and looking ahead, the Board shall follow the aspiration of people-based governance. The Board shall work closely with people in law, healthcare, psychology and social work with a close connection with the nature of our work as well as people who have had personal experience with mentally incapacitated persons, to continue to develop our expertise and enhance the accessibility of our procedures to provide help to mentally incapacitated persons within the statutory framework of the Mental Health Ordinance.

I invite readers to review the work that we have performed in the past few years. In this connection, I must extend my gratitude to all individuals and bodies who contributed to our work and especially to the Labour and Welfare Bureau, Social Welfare Department, Judiciary, Department of Justice, Official Solicitor's Office, Hospital Authority and our Board members and staff.

II. Our Operations

A. The Role of the Guardianship Board

1. The Board's Identity

The Guardianship Board ("the Board") was formed in 1999. It was established as an independent body in the Hong Kong Special Administrative Region under the Mental Health Ordinance (Cap. 136 of the Laws of Hong Kong) ("MHO"). Under section 590 of the MHO, Guardianship Orders may be made to protect the interests and welfare of the mentally incapacitated persons aged 18 years or above who are incapable of making their own decisions on their personal affairs, financial matters or medical (including dental) treatment as provided under the MHO and who must be received into guardianship for their protection. The Board's role is to conduct hearings of applications for Guardianship Orders.

The Board may make Guardianship Orders appointing guardians to exercise one or more of the powers under s59R(3), which are summarized briefly as²:

- ♦ to require the Subject to reside at a specific place;
- ♦ to convey the Subject to a specific place and use reasonable force for the purpose;
- ♦ to require the Subject to attend at a place and time for medical or dental treatment, special treatment, occupation, education or training;
- ♦ to consent to medical or dental treatment if the Subject is incapable of understanding the general nature and effect of the treatment;
- ♦ to require access to the Subject to be given to any doctor, approved social
 worker or other person specified in the Guardianship Order;
- ♦ to hold, receive or pay a specified monthly sum for the maintenance or other benefit of the Subject (the currently maximum amount is HK\$18,000 per month).

Where there are descriptions of provisions in this document, the wording of the Mental Health Ordinance shall prevail.

2. The Board's Work

The Board has three panels. One member from each panel is appointed to sit at hearings, which are to be presided by the Chairperson or one of the presiding members from the legal panel (Panel A). Panel B members are those having experience in assessing or treating mentally incapacitated adults such as registered medical practitioners or social workers. Panel C members are persons who have had personal experience with mentally incapacitated persons. The composition of the panel members ensures the interests of subjects are assessed from different angles, whilst advancing and protecting their interests and benefits.

3. Types of Cases Handled

Under Part IVB of the MHO, the Board's jurisdiction over guardianship of persons rests on the definition of who is a "mentally incapacitated person". Mental incapacity is defined by reference to "mental disorder" and "mental handicap".

In practice, most of the cases handled by the Board can broadly be categorized into the following types:

- ♦ Dementia
- ♦ Mental Handicap
- ♦ Mental Illness
- ♦ Stroke

Not all MIPs who have a mental disorder or a mental handicap will require guardianship. The Board will have regard to certain criteria laid down in the MHO before determining whether a Guardianship Order should be granted. Please refer to Table 7.




B. Caseload and Major Statistics













V. New Developments

1. Personal Data Protection

The Board introduced new measures as from April 2021 to enhance the protection of personal data of applicants, mentally capacitated persons and their relatives. This included encryption of document exchange with Board Members and internal guidelines for handling documents and response to public enquiries.

2. <u>Promotion of Racial Equality</u>

The Board supported the Government's initiative to promote racial equality. Since November 2020, the Board became ready to render our services to people of different races and ensured their equal access. This included taking the following steps: -

- (1) Posted cue cards in reception areas at 7/F & 8/F for visitors;
- (2) Created a new page "Other Languages" under our official website;
- (3) Posted 8 translated versions (not only English and Chinese versions) of the "Checklists of Measures" on our website;
- (4) Our versions of the "Checklists of Measures" were posted on the government website; and
- (5) Posted 8 translated versions (not only English and Chinese versions) of the "Annual statistics" on our website.

3. Monthly Statement

In order to assist guardians to keep income and expenditure accounts, the Board has enhanced its forms for "Monthly Statements" and "Final Statement (Cumulative)". The new forms are in Excel format and in Chinese and English respectively. Guidance notes are also included with the forms and in the updated Leaflet 15 entitled "The Guardian's Financial Management Power". The new forms were launched on 31 December 2021 with an effective date of 1 January 2022. The public can download the said information from the Board's website. A soft transitional period of six months has been agreed with the Social Welfare Department.

4. Financial Inclusion

The Board responded to the consultation conducted by the Hong Kong Monetary Authority (HKMA) and the Hong Kong Association of Banks on "Guideline on Banking Services for Persons with Dementia".

We are grateful to the HKMA for keeping us informed when their Guideline was launched on 10 December 2021. The Board relies heavily on the co-operation and understanding of banking institutions of our work and the needs of guardians. We look forward to further collaboration with the HKMA and the banking sector to enhance the operation of guardian accounts and other related matters.
